I took Suzanne to see Dr. Rose Giammarco (Neurologist) yesterday. Dr. Rathbone made the referral in hopes of getting Suzanne some relief from the constant pain in her head.

After providing Dr. Giammarco with some medical history, including the injury Suzanne sustained while in hospital, Dr. Giammarco urged us to ask you about getting Suzanne's treatments covered through the lawsuit. Not sure if this is even possible or how it would work, but Dr. Giammarco seemed to believe that this was an option.

Dr. Giammarco suggested a couple options for treatment. She believes that Suzanne would benefit from Botox injections with minimal or no side effects. The cost of this treatment prevents Suzanne from this option. Dr. Giammarco asked that I get back to her once I have contacted you to see if there was a way to get Suzanne's treatments covered.

The second option is an oral medication but there are side effects, which include a loss in cognitive skills. She prescribed this medication and suggested that Suzanne be kept under a watchful eye for any signs of concern and to call her or one of Suzanne's treating specialists immediately.
