Another contact that you may be of assistance is a woman by the name of Flo Kerr. Ms. Kerr worked in HR with the Dufferin-Peel Catholic District School Board and was considered to be one of Manpower's largest and most important client during Suzanne's employment with Manpower. The portfolio was assigned to Suzanne because of her experience.
